

#### 2. KEY FUNCTIONS


- Organization, coordination and supervision of all the functions entrusted to the Office of the Leader of the Opposition of Parliament.

- Preparation of the List of Speakers taking part in the Parliamentary Sessions on behalf of the
   Opposition and allocation of time for them.
- Submission of the questions, to be raised under the Standing Order No. 23/2 submitted by the Party Leaders of the Opposition Group, to the Secretary General of Parliament.
- Submission of the Adjournment motions and questions, presented by the Hon. Members of the Opposition, to the Secretary General of Parliament and communication with them on the dates on which such motions and questions to be taken up for debates or clarifications.
- Presentation of the Questions, submitted by the Hon. Opposition Members, in order to obtain answers from the Hon. Prime Minister, to the Secretary-General of Parliament.
- Arrangement of the activities related to convene the Hon. Members of the Opposition when the Divisions are expected to call in parliament and maintenance of the records of the attendance of the Hon. Members, in such occasions.
- Submission of the nominations of Hon. Members of the Opposition in relation to the Sectorial
   Oversight Committees to the Secretary –General of Parliament.
- Provision of details on the meeting schedules of the Sectorial Oversight Committee Meetings to the Hon. Members via e-mails and SMS.

- Coverage of the Sectorial Oversight Committee Meetings to facilitate the Hon. Members of the opposition, when required.
- Nomination of the Hon. Members of the Opposition for the Inter Parliamentary Union,
   Commonwealth Parliamentary Association, SAARC Parliamentarians' Association and other relevant foreign conferences, workshops and training programmes.

- Submission of background reports, information, documents and court determinations, etc.

  of the Budget in three languages, on receiving the approval for the draft schedule, relevant to
  the Third Reading of the Budget and distribution of its printed copies.
- Translation of the documents, which are required to the Hon. Members of the Opposition, into main three languages.
- Submission of leave applications of Hon. Opposition Members anticipated to travel abroad, to the Hon. Leader of the Opposition for approval.
- Provide the required assistance to the Hon. Leader of the Opposition to perform his representation at different forums with in the Parliament and outside.
- Maintenance of a database including the updated communicating particulars of all the Hon.
   Members of the Opposition.
- Provision of required assistance to the Hon. Members of the Opposition during the entire
  period of every sitting day, assigning the officers of this office in the booth reserved for the
  Secretary to the Leader of the Opposition.
- Preparation of files contained all the document (Bills, gazettes, regulations and amendments
  to the acts, etc.) related to the parliamentary programme of each sitting week delivery of them
  by hand to each Party Leader of the Opposition group in the Parliament for their timely
  reference.

- Organization and coordination of discussions in respect of the diplomatic officers, foreign delegations and other guests of the Hon. Leader of the Opposition and provision of necessary facilitates for them.
- Arrangement of obtaining necessary information, from the local and foreign institutions and persons, as required by the Hon. Leader of the Opposition.

- Extension of cooperation required from this office to the Secretary- General of Parliament and his staff in the fulfilment of their duties.


# 3. COMPOSITION OF THE OFFICE OF THE LEADER OF THE OPPOSITION

#### 5.1 General Performance

- 2. The Opposition representatives of the Committee on Parliamentary Business were informed on 32 meetings.
- The officers representing the office of the Leader of the Opposition have participated in 32
   Meetings of the Committee on Parliamentary Business.
- 4. Action was taken to prepare speakers' Lists of the Hon. Opposition Members took part in 97 Parliamentary sessions on behalf of the Opposition and to allocate time for such debates.
- 5. 78 Questions, raised under the Standing Order No: 23/2 by the Party Leaders of the Opposition Group have been forwarded to the Secretary General of Parliament.
- 6. Steps have been taken to submit 38 Adjournment Motions and 06 Adjournment Questions forwarded by the Hon. Members of the Opposition, to the Secretary-General of Parliament and to kept the Hon. Members aware of it.
- 7. 14 Questions, submitted by the Hon. Opposition Members, to ask from the Prime Minister were sent to the Secratary-Genearal and the relevent Hon. Members were made aware of them.
- 8. 33 Nominations of the Hon. Opposition Members have been submitted with regard to the Inter Parliamentary Union, Commonwealth Parliamentary Association and SARCC Parliamentarians' Association and Three Hon. Opposition Members were nominated for the foreign tours.
- 9. Required background reports, information, and documents have been provided to the Hon. Members of the Opposition when they solicited such details.
- 10. Action was taken to prepare the booklet contained the schedule of the Committee Stage Programme of the Budget-2017 in three languages, and to print 5000 copies of it and distribute them.

11. Action was taken to keep the Hon. Members of the Opposition informed on the schedule of meetings of the following Sectoral Oversight Committees and their sub committees through e-mails and SMS and to maintain minuets of such meetings and to provided requried information to the Hon.
